The patient Ranjeet Kaur was presented with the H/O RTA and chief complaints of an episode of unconsciousness, fracture of the femur, severe pain in right arm and right leg, multiple abrasions, fever and headache. One day for HDU was auto approved on 10/11/2020 after the patient registration. The first preauthorization was initiated for HDU for 5 days on 11/10/2020 by the hospital and got rejected on 12/11/2020. The second enhancement was initiated for general ward for three days on 12/11/2020 and got approved on 14/11/2020.


Findings:

As per the TMS, the patient was admitted under the package severe sepsis (MG002A)as TLC in CBC report conducted on 07/11/2020 was raised i.e. 18400. However, during the medical audit conducted on 13/11/2020 when our team cross-checked the patient was found to have # Femur as per the X ray available in the hospital records and patient's relative admitted that the patient had undergone surgery for the fracture of the femur. Therefore, a surgical procedure was done by the hospital but, on the other and, the package blocked was a conservative package. Also, it had been observed that the CBC report as per lab register dated 07/11/2020 shows a different TLC count (12,400) than the report provided on TMS i.e. 18400dated 07/11/2020. Thus, there was a mismatching of the documents. Moreover, a aurgery cannot be performed at such high TLC count (18400). Hence, the hospital was fabricating the reports to justify the package blocked on TMS. Furthermore, it was observed that the AB-SSBY eard of the patient which the hospital helped the Patient to make their Card and charged as:1500/- for the same (as per patient's relatives statement) was also incorrect. However, the patient was the beneficiary of AB-SSBY. Patient was asked by the hospital to get an Ayushman card made and the hospital will help in making it. Patient's Ayushman card was made by PMAM of CHC Tasreeka and the patient was charged Rs. 1500/- by the Swift Hospital itself. Also, it had been observed that hospital had taken money of Rs. 1900/- on 07/11/2020 with bill receipt number 5395, Rs. 33000/- on 10/11/2020 with bill receipt number 5420 and Rs. 5000/- on 11/11/2020 with bill receipt number 5425 during the hospital stay for blood investigations and surgery. In a video statement of the hospital dated 13/11/2020 of the hospital staff had admitted about the cash received by the hospital. In another video statement, the patient's relative had also admitted the aforementioned discrepancy. Patient's family had also made an allegation that the hospital had harassed them to deposit money but, on the other hand, the hospital got a consent signed from the patient's husband that they didn't charge any money. The family had raised a complaint about the same to Deputy Medical Commissioner, Amritsar on 12/11/2020.

Observations:

- 1. A surgical procedure had been performed. Although, the package blocked was a conservative package.
- 2. The hospital had taken money from the patient for investigations and surgery (also government reserved procedure) and tried to book it under medical management, when the case was highlighted the hospital tried to put an early discharge date on the TMS to save them.
- There was a fabrication of the reports to justify the package blocked on TMS and document mismatch. The TLC count on TMS is different from TLC count mentioned on the lab register.

However, our team will conduct live audit if any fresh claims is submitted by this hasaital in future and process the claims with more caution

3. In the complaint the complainant has attached cases of swift hospital, which stands suspended from the scheme, hence necessary action stands taken by the SHA Authorities.
